

CHARLBURY TOWN COUNCIL

Meeting of Charlbury Town Council held on Wednesday 29th July 2009 at 7.30pm in the Corner House.

Members Present: Mr R N Potter (Chairman), Mrs S Finch, Mr J Harrison, Mrs H Bessemer-Clark, Mrs N Lethbridge, Mr R James, Mr. R Prew, Mr W Hackmann, Mr I Cox, Mrs V Pakenham-Walsh and Ms L Reason.

Prior to opening the meeting the Chairman reported as following:-

The Clerk and his wife had attended a garden party at Buckingham Palace on 14th July to recognise 30 years service to the Council.

A meeting of principal charity chairmen had taken place on 20^{th} July where the purpose, aims and current plans of each were discussed. The purpose overall being to ensure that each Charity is aware of others in the Town and to seek to avoid clashes in seeking finance but also to promote idea exchange and support. Three members of Council were present M/s Reason (Gifford) Mr Prew (Museum) and Mr Harrison (Fire Brigade Fund). The Clerk acted as chairman/facilitator. When available aims/objectives to be circulated.

The Gifford Charity held a very successful public meeting on 10th July and Mr Jones, the Chairman, has been invited to the September Council meeting (Planning) to update members.

1. To receive the minutes of the last meeting.

Mr Hackmann proposed that the minutes be signed as a correct record, this being seconded by Mrs Finch and agreed.

2. To deal with matters arising.

Cornbury Festival. No complaints received by this Council. One email congratulating the organisers on the improved traffic management in Park St/ N.Lodge area had been received and passed to the organisers.

Other matters are agenda items.

3. Declaration of Interest

There were none

4. To sign orders for payment / receive report.

The accounts due for payment were circulated and explained. Mr Hackmann proposed that the accounts be paid this being seconded by Mr Cox and agreed. Accordingly cheques were signed by three Councillors.

5. To receive a report from the Planning Committee.

The following plans were considered:-

09/0710 Signage at the Coop Enstone Rd.

Mr Westerman had recently (27th July) addressed Council, with Miss D Brodie on the subject of revisions to permitted development and had discussed the decision process on a number of previous applications of concern which included the above.

He reported that since the Council was invited to comment (June) the applicant had presented an amendment to the drawing proposed.

This had not been subject of further consultation but if comments were received prior to the Uplands meeting on 3rd August concerns would be reported to committee. Accordingly the following comments were agreed:-

- 1. The Town Council endorses its original comments and strongly objects to the changes made by the applicant.
- 2. The Council asks that all three signs proposed be reduced in size and the shape modified to match those existing (i.e. round with the dimensions not exceeding those of the signs currently in place)
- 3. Two photographs are attached which demonstrate the objections raised and we ask that those be shown to committee side by side to enable a comparison to be made.
- 4. Any white background to be of a muted tone not stark white as shown.

7. To consider Chairmanship and Procedures

Following the circulation of a paper in May it was agreed that there should be the following changes to procedures:-

- 2. To hold strategic / reflective meetings twice per year.
- 3. To include a Clerks actions report as a standing agenda item.

8. To receive reports with reference to Charlbury

<u>a. County Councillor</u>:- Mr Owen reported as follows:

- 1. He was in dialogue with Paul Wilson with respect to the state of the highways in Charlbury. He is personally undertaking an audit in Charlbury.
- 2. Clerk and County Councillor to copy in each other on correspondence.
- 3. Weeds budget no longer exists hopes to get Probation Service to undertake if scheme is suitable.
- 4. Will enquire about grass clippings in road when OCC contractor cuts verges and will also take up Market St footpath issues.

<u>b. District Councillors:-</u> Mrs Chadwick reported as follows:

- 1. Review of officer sharing (Chief Exec.) with Cotswold DC.
- 2. Cabinet agree £30k grant to Pavilion rebuilding.
- 3. To take up issues of litter outside fast food premises.

Mr Breakell reported as follows:-

- 1. Meeting with Planning officers, Town Council and Conservation Cttee was useful.
- 2. New Barn Farm enforcement action has been recommended
- 3. To take up a request from Mr James that information be sent, with approved application, including information on energy efficiency grants etc and how to improve such matters as an automotive process.

9. To appoint a Trustee to the Gifford Charity

Mr Hackmann, one of three Council nominees, has reached the end of his term of office.

Mr Prew proposed that Mr Hackmann be this Councils nominee being seconded by Mr James and carried nem con

Letter to be sent to the Trust Chairman.

10. To consider affordable housing

The Chairman reported that two exploratory meetings had been held. This had resulted in the following:-

- 1. Existing housing need to be circulated i.e. update of the last survey. This will be published on the web site and by posters.
- 2. Preliminary sketches to be prepared based on the need identified.
- 3. Extra care housing. A site in West Oxon is required. This should be kept in mind though unlikely to be permitted on an exemption site.

11. To consider a web-site proposal

A paper has been circulated with a date for comments to be received by the Clerk. August agenda item.

12. To appoint a representative to the Primary School Governing body

Mr James proposed Mr W Hackmann fill the vacancy created by Mrs Epps standing down, this being seconded by Mrs Bessemer-Clark and carried nem con. Letter of thanks for her service to Mrs Epps.
