

# CHARLBURY TOWN COUNCIL

### Meeting of Charlbury Town Council held on Wednesday 23rd September 2009 at 7.30pm in the Corner House.

BDO Stoy Hayward The report of the external auditor was read to members. This suggested that the fidelity bond within the Insurance policy should be sufficient to meet the value of deposits plus precept. Currently at £150,000 this was, in the auditors view, in need of increasing. The remainder of the report was entirely satisfactory.

M/s Reason proposed that the report be accepted and that the fidelity bond be increased to £250,000 at the next renewal of the insurance policy (Feb 19<sup>th</sup> 2010) this being seconded by Mr Hackmann and agreed.

#### 7. To consider affordable housing

The consultation period to update the needs survey will conclude at the end of October at which point further meetings will take place to consider how best to proceed.

#### 8. To receive an allotment report.

Three members viewed the two sites and instructed the Clerk with regard to three plots needing attention at Oxpens together with some maintenance at both sites. Current waiting list is eleven.

Co-op Signs. A reply to Mr Owens letter referring to the need to scale down the proposed new sign was read. The Coop had listened and the signs were now acceptable and in place. Mr Owen was thanked for his efforts on this matter.

Dean Pit. Decision meeting has been postponed until 22<sup>nd</sup> October.

Street Lighting. Chadlington have agreed to switch off.
