

CHARLBURY TOWN COUNCIL

Meeting of Charlbury Town Council held on Wednesday 25th January 2011 at 7.30pm in the Corner House.

Prior to opening the meeting the Chairman wished all present a belated Happy New Year. He went on to make the following points:-

Chairman's Reception was to be held on 8th February at 7.00pm.

He had attended an OROC meeting at Carterton celebrating small rural towns (no other Charlbury Councillors present).

There is at present no roadshow for Neighbourhood Planning OALC/ORCC are organising an event for this purpose on 12th March at Exeter Hall Kidlington (6-9.30pm). Two attendees are permitted.

1. To receive the minutes of the last meeting.

Mrs Pakenham-Walsh proposed that the minutes be signed as a correct record this being seconded by Mrs Lethbridge and agreed.

2. To deal with matters arising.

The Chairman and Clerk met two representatives from Wilderness Festival (Eloise Markwell-Butler and Dave Mc Calmant). This years dates will be $10^{th} - 12^{th}$ August. There was considerable discussion concerning the noise at 3.00am on the Sunday morning and the use of TENS licences to extend the Festival hours beyond the premises licence (2.00am). There had been an issue with an event advertising itself to 3.00am. There will be a SAG meeting with WODC to prepare conditions for this years event and Lord and Lady Rotherwick will attend the TC meeting on 20^{th} February to discuss events planned for 2012.

Queens Diamond Jubilee. Clerk exploring various possible ideas raised by the working group.

Library. Friends AGM 6th February. Speakers from OCC will be present.

Liz Reason outlined the condition in the grant document from OCC re the provision of Library facilities at the Community Centre.

Planning The Clerks notes were considered of some use. System to continue.

Footpath at Little Lees

A letter from some residents was considered at the Planning meeting and the Clerk was requested to seek further details on the process which led to the addition of this path to the plan for this site. There was some reference to the application being advertised over the Christmas period.

The Clerk reported that OCC had requested that the path be included as a condition of their approval. Accordingly the application was made and included in the committee decision at WODC Uplands planning.
