

CHARLBURY TOWN COUNCIL

Meeting of Charlbury Town Council held on Wednesday 25th July 2012 at 7.30pm in the Corner House.

Mrs Anne Lloyd addressed the meeting and spoke of her concerns at the amount of weed growth in very many locations in the Town. She demonstrated this with a series of photographs of affected locations. She felt that the Town could be looked after better perhaps using a local person employed by the Town Council. She went on to say that she believed that OCC did not adequately monitor their contractors and this coupled with acceptance of lowest tenders could be a contributory factor. She believed residents should not have to do the work whilst appreciating those that did.

The Chairman thanked Mrs Lloyd for her presentation. He reported attendance at the County Scout AGM on 11th July and that the Charlbury beavers had won a bronze award from the Chief Scout.

He reminded Members that any gift or hospitality accepted for the Wilderness Festival would have to be declared.

7. To receive reports with reference to Charlbury

a The County Councillor Neil Owen reported as follows:

- 1. He has activated a request for weeds to be cleared at The Green
- 2. He will follow up with other areas of need.
- 3. OCC has a Health and Wellbeing Board taking back certain responsibilities from the NHS.
- 4. Library volunteer training proceeding.
- 5. Thornhill park and Ride lack of parking spaces has been put to relevant Cabinet Member (Mr Rose)

b. District Councillors Liz Leffman reported as follows

- 1.Lots of time spent on issues relating to the Spendlove recycling site. There is some concern as to the Management of this part of the waste contract. Other street bins and those in recreational areas are also not being emptied sufficiently frequently.
- 2. A further bin is to be provided at Spendlove to enable the disposal of small electrical appliances.
- 3. Has been involved in the Beacon project and is supportive.
- 4. Has helped in seeking grant for Memorial Hall.

Hywel Davies reported as follows:

- 1. 93% support on web site for Greystones proposal
- 2. The facility will provide useful facilities to promote swaps, training etc and is likely to seek planning consent in early September. Online early 2013

9. To consider Neighbourhood Planning

Meetings/seminars are being attended in preparation for future discussion. Mr Fairhurst has uploaded the Town Appraisal and traffic survey to the website.

The Chairman reported briefly on the meeting at WODC attended by him and the Vice Chairman where several additional issues had been raised over and above Neighbourhood Planning. There will be a need to watch issues relating to Council Tax/Precept caps and similar. Developments awaited.

The reflective meeting on 17th October will concentrate on Neighbourhood Planning. The County and District Councillors invited to attend and participate.

10. To consider the August Surgery arrangements

The 'surgery' on 4^{th} August will be held with Councillors Pakenham-Walsh and James in attendance. October arrangements to be made at August meeting – Agenda item.
