# Virtual meeting of Charlbury Town Council held on Wednesday 24<sup>th</sup> February 2021 at 7.30p.m.

The Chairman welcomed those present and reminded them that public participation was only possible for a short period by prior arrangement. No such applications had been received.

# 1. To receive the minutes of the last meeting

Mr Potter proposed that the minutes be signed as a correct record, seconded by Mr Kenrick and agreed.

## 2. To deal with matters arising.

**Cottsway.** Mr Kenrick had circulated a course of action proposed by the working group which covered all issues previously considered. It went on to set out a series of conditions of engagement and transparency. These were agreed. Meeting to be arranged subject to acceptance of conditions, all without prejudice. Proposed Mr Potter seconded Dr Merry and agreed.

Wigwell House. Planning Breach. No reply yet from WODC.

1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.

1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.

#### 21/00036/HHD Alterations at 14, Nine Acres Close.

1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.

(N.B. Mr Fairhurst made no comment on this application save to declare an interest.)

### 21/00144/HHD Extensions at Shadbolts, Hixet Wood.

1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.

#### 21/00162/HHD Conversions and extensions at Lamorna, Stonesfield Lane.

 We have no objection and applaud the attention given to sustainability and addressing the challenges of the climate emergency, including the deployment of a ground source heat pump.

# **21/00163/HHD** Alterations and additions at Gladstone House, 2 Wychwood View, Woodstock Road.

- 1. There appear to be some errors in the application form (Section 13 ownership certificates) and attached notices which give the address as Chadlington instead of Charlbury. House number given as 1 instead of 2.
- 2. Energy efficiency must be a particular concern for such a large glass structure as proposed but this is not addressed in the D&A statement or anywhere else in the plans. ( Policy NE9 of the emerging N/H Plan). This is relevant in view of climate change.
- 3. Otherwise no objection.

#### **21/00146/HHD** Construct garage, gym and outdoor pool at Brockwell House, Spelsbury Road.

- 1. We have no objection but in the interests of efficient use of energy and climate change we are concerned at the lack of information regarding:
- a. Associated equipment (Plant room).
- b. If the pool is to be heated could a commitment to minimising nett energy consumption be gained i.e installing solar panels or ground/air source heat pump?

#### 21/00197/HHD Front extension at Florence Corner, Fishers lane

1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.

#### 21/00231/FUL Extensions at Bowls Club, Ticknell Piece Road.

- 1. We have no objection but ask that the highest standards of energy efficiency be used in view of climate change.
- 2. We welcome the improvements to this very well used facility.

Appeal Decision.. 19/02855/FUL The Gables 10, Enstone Road.

WODC refusal of consent to build a house on part of the plot was upheld by the Inspector.
